Pursuant to Article 28 and Article 19 of the Law on Protection of Competition ("Official Gazette of the Republic of Macedonia" no.145/10 and 136/11), and following the notification of concentration between Acibadem Saglik Hizmetleri you Tidzharet A.SH. on one hand and private health institution in mixed ownership - Clinical Hospital SISTINA Skopje Association of Commerce and services for medical equipment Acibadem Sistina Medical Company LLC Skopje on the other side, and submitted jointly by Acibadem Saglik Hizmetleri you Tidzharet A.SH.i Company for production, trade and services Orka Holding AD Commission for Protection of competition on the session held on 13.10.2011, has adopted the following

DFCISION

- 1. The concentration between Acibadem Saglik Hizmetleri you Tidzharet A.SH. with main office at Tekin Street No.8, Kadıköy, Istanbul, Turkey on one hand and private health institution in mixed ownership Clinical Hospital SISTINA Skopje based at street. 5 Skupi Skopje Association of Commerce and services for medical equipment Acibadem Sistina Medical Company Ltd Skopje based at street. 5 Skupi Skopje on the other side on the basis of trading shares, although it falls under the provisions of the Law on Protection of Competition, will not result in significant prevention, restriction or distortion of effective competition in the market or its significant part, particularly as a result the creation or strengthening of dominant position of the participants and is in accordance with the Law on Protection of Competition pursuant to Article 19 paragraph (1), item 2) of the Law on Protection of Competition.
- 2. It obliges the notifying concentration party to pay an administrative fee for reporting of concentration in amount of 6000, oo den. and decision amounting to 30,000, oo den. after heading 28-a of the Administrative Fees ("Official Gazette of the Republic of Macedonia" no.17/93, 20/96, 7 / 98, 13/01, 24 / 03, 19/04, 61/04 and 95/05) against the account of the Budget of the Republic of Macedonia no. 100000000063095, and suspense account 840 03161, income code and program 72231300.

Guidelines for legal remedy:

Against this decision a complaint can be lodged for initiating administrative proceedings before the Administrative Court of the Republic of Macedonia within 30 days of its delivery.
